RULES AND REGULATIONS

1. Name of the Society : GOVERNMENT DEGREE COLLEGE CHEBROLE ALUMNI ASSOCIATION

2. Address : Government Degree College campus, Chebrole, Guntur District, Andhra Pradesh, Pin 522212.

3. Membership :

All the members (old students, Teaching staff and Administrative staff of Government Degree College, Chebrole, Guntur district, Andhra Pradesh) who have completed 21 years of age can join as members of the Society irrespective of caste. For that admission fee of Rs. 100/- (rupees one hundred only) shall be paid. Every members shall pay Rs.50/- (rupees fifty only) towards annual subscription for the period from 1st April of that current calendar year to 31st March of the next calendar year. Any member who fails to pay the annual subscriptions for three consecutive years shall lose their membership or who fails to attend the General Body or Executive Body meetings for three consecutive times shall lose the membership. The Executive Body has right to remove the membership, if the Rules and Regulations of the Society are not followed any member.

4. General Body Meeting:

All the Members who have joined as per Rule 3 shall be the members of the General Body Meeting. This shall meet in the month of September every year and conduct the following activities.

- To elect the Executive Committee once in every three years.
- To prepare the budget for ensuring year.
- To approve the receipts and expenditure statements of the previous year.
- To appoint an Auditor if necessary
- To prepare programs for the development of the Society.

5. Executive Body:

The Committee shall be managed by a Managing Committee consisting of the Teaching Staff, Administrative Staff and old students of the College initially constituted by the Head of the Institution, as :

6. Functions of the Executive Body:

- a. To disseminate information gained through several service organizations and to incorporate them in the proceedings of the Association.
- b. To organize programmes inculcating the spirit of sacrifice and generosity from the gross route level of the hearts of the student community.
- c. To encourage the spirit of one-ness in helping the poor and needy students.
- d. The members of Alumni Association shall meet at least once in a year or in a specified time and discuss about the development activities of the college and to organize welfare programmes in the College.
- e. If vacancy arises in the middle, they shall be elected from the General Body Members through co-option and shall remain in the vacancy till the elections are conducted.

DUTIES OF THE EXECUTIVE BODY:

- 1. President:** (Principal of the College is Ex-office Chairman of the Association). He/ She preside over all the Executive Body and General Body meetings. He/ She shall have power to inform the Secretary for organizing the special meetings at the request of not less than 3/5th executive members or majority of the General Body. He/ She will have a casting vote in this.
- 2. Vice-President:** In the absence of the President, Vice-President shall perform the duties of the President temporarily.
- 3. Secretary:** He/she prepare the minutes of the Association of all the meetings budget and expenditure statements. He/ She shall prepare agenda for all meetings. He/ She shall collect the membership fee subscriptions donations, contributions and other to raise the funds of the Association according to the rules. He/She shall expend the amounts sanctioned in the budget subject to the approval of the Executive Committee. He/She shall send notice for all meetings 7 days well in advance. He/ She can represent the Association in all legal matters. He/ She shall maintain all property and records of the Association. He/She shall maintain files and other relevant correspondence papers. He/She is the main empowered to deal with all the matters relating to institution. He/ She operate the bank accounts of the Society jointly with Treasurer.
- 4. Joint Secretary:** In the absence of the Secretary, they shall perform the duties of the Secretary temporarily.
- 5. Treasurer:** He/She shall receive all amounts collected in the name of association and shall deposit in the Bank in the name of Association within 3 days from the date of collection. He/She shall maintain the accounts properly and produce them with all necessary vouchers in the executive body and general body. He/ She shall observe the accounts yearly for the period from 1st April to 31st March of every financial year.

6. Executive Members: They shall always strive for the development of the Society along with the above.

7. Quorum:

The Quorum of the General body and Executive Committee should be 3/5th of the members on rolls.

8. Funds:

The funds of the Alumni Association of the College shall be spent only for the attainment of the objects of the Association and no portion thereof shall be paid directly or indirectly to any office members by any means. Everyone, who joined in this Alumni Association of the College as a member shall pay a nominal fee of Rs.50/- per annum as yearly subscription as mentioned under Rule 3 above, so as to make the Association of the College long lasting and self is sustaining.

9. Amendments:

No amendments or alteration shall be made in the objectives and Rules and Regulations of the association unless it is voted by 3/5th of the members present at a General Body Meeting convened for the purpose and confirmed by 3/5 of the members agreed at the second Special General Body Meeting.

10. Liquidation:

If the Alumni Association of the College in future felt necessary likely to be liquidated all the properties remained by that date shall be transferred to any other society having similar aims and objectives only after obtaining the acceptance of three fifth of the majority of the General Body Meeting.

11. General:

All the provisions of the Societies Registration Act 35 of 2001 not specifically mentioned herein shall also apply to this.
