

MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

**1. Government Degree College, Chebrole,
Guntur district, Andhra Pradesh**

AND

**2. Government College for Women (Autonomous),
Guntur, Guntur district, Andhra Pradesh**

*‘To collaborate in Faculty exchange, student exchange,
infrastructure exchange and sharing of human resources’*

This Memorandum of Understanding (MoU) is entered into on the **25th day** of January in the year 2020 by and between **Government Degree College, Chebrole, Guntur District, Andhra Pradesh** and **Government College for Women (Autonomous), Guntur, Guntur district, Andhra Pradesh**.

1. The objectives of this MoU are as follows

- a) To promote and enhance academic and field knowledge between *Government Degree College, Chebrole, Guntur district* and *Government College for Women (Autonomous), Guntur, Guntur district*.
- b) To provide advice for implementation of quality of education.
- c) To provide academic interaction by delivering special lectures on topics relevance to computer Subjects.
- d) To provide necessary help in organization of workshops/conferences and personality development programmes at *Government Degree College, Chebrole, Andhra Pradesh, India*, for enhancement of skills in respect of students.

2. Proposed modes of collaboration

- a) The above goals will be accomplished by undertaking the activities like *Study material development, Developing e-content, Faculty Exchange, Student Exchange, Infrastructure exchange, Guest Lectures, Training Programmes, Workshops etc., for students and faculty*.
- b) The Party-1 may request some of the faculty or students of Party-2 to address the faculty or students of Party-1 and vice-versa.

c) *Both the parties may conduct Guest Lectures, Training Programmes, Workshops etc., to enrich teaching learning process at their interest and convenience.*

d) The In-charges of the concerned Departments will monitor the programmes.

3. Funding

There is no financial commitment.

4. Terms of MoU

The duration of the MoU will be for five years from the date of execution and can be extended for another two years with the mutual written consent of both the institutions/firms. This MoU may be terminated without any cause by either party upon two months written notice, which shall be delivered by hand or by registered email or by post or courier.

5. Signed in Duplicate

The MoU is executed in duplicate with each copy being on official and legally valid document. This is signed by duly authorized officers of *Government College for Women (Autonomous), Guntur, Guntur*

district, Andhra Pradesh and *Government Degree College, Chebrole,*
